Important Note: Candidates who have already undergone Graduate or Technician/Diploma Apprenticeship Training in respective field are not eligible to apply.

#### 1. Online Registration in NATS portal:

The candidates i.e. prospective Graduate / Diploma Apprentices shall register themselves on the NATS portal. Further, the candidates shall also be required to upload on the portal the documents mentioned below in this advertisement. Then the candidates shall apply in the portal for Graduate / Diploma Apprentices.

#### 2. Age Limit:

For Diploma Holders (Technical): Between 18 to 22 years as on closing date of application.

For Graduates (Technical)

: Between 21 to 25 years as on closing date of application.

Important Note: If the joining date of the candidate for Apprenticeship Training in this Factory is more than 5(five) years from the date of passing Diploma / Graduation, then the candidate will not be eligible under the National Apprenticeship Training Scheme (NATS) for the Office.

#### Relaxation in upper age limit is permitted for:

SC/ST Candidates : 05 (five) years.

OBC (Non-Creamy Layer) Candidates : 03 (three) years.

Persons with Physical Disabilities : 10 (ten) years.

#### 3. Essential Qualification:

- A degree in engineering or technology granted by Institutions empowered to grant such degrees by an Act of Parliament.
- ii) Graduate examination of Provisional bodies recognized by the Central Government as equivalent to a degree.
- iii) Sandwich course student who is under-going training in order that he may hold a degree in engineering or technology as mentioned at (i) and (ii) above.
- iv) Diploma issued by institutes approved by AICTE.

#### 4. Documents / Information Required:

- i. University Regn. No./ Roll No. /Enrol. No.
- ii. List of elective subjects studied during Degree in Engineering / Technology / Humanities etc.
- iii. Details of additional short term / certificate courses.

## 5. Other documents to be kept ready for uploading on the portal:

- i. Any one of the Government IDs (Driving License, Voter Card, Passport, PAN Card) mandatory.
- ii. Aadhaar Card/Proof against registration for issue of Aadhaar Card ... Mandatory.
- iii. Valid personal email ID .... Mandatory.
- iv. Mobile number will be required to enter OTP .... Mandatory.
- v. Passport size photograph Format : JPEG, Size : Less than 200 kb ... Mandatory.
- vi. Bank A/C details ..... Not mandatory (at the time of online application)\*
- \* Bank A/C details is optional during enrolment; however, it is mandatory at the time of Contract creation after engagement as Apprentice.

#### 6. Enrolment for NATS:

- By accessing the students tab, candidates can register for apprenticeship training through the NATS web portal.
- ii. The guidelines mentioned on the NATS portal https://nats.education.gov.in/ shall be followed.

#### 7. Reservation Policy:

Reservation policy in engagement of Apprentices shall be applicable as per Apprentices Act, 1961 and Apprenticeship Rules, 1992 & 2015 or as per extant Government of India Rules regarding engagement of Apprentices.

#### 8. Duration of Training:

Duration of Apprenticeship Training period is specified in the Apprentices Act, 1961, Apprenticeship Rules, 1992 and amendments thereof. However, the period of Apprenticeship Training in the case of Engineering Graduates and Diploma Holders shall be one year.

#### 9. Stipend:

The minimum stipend per month shall be paid to the Apprentices as per the provision of Sub-Rule (1) of the Rule – 11 of the Apprenticeship Rules, 1992. The stipend to be paid to the Apprentices per month shall be –

Technician apprentices or Diploma Holder in any stream or sandwich course (students from degree institutions)	1	
Graduate apprentices or degree apprentices or degree in any stream	Rs.9000/- per month	a .

No other allowances will be paid during the entire period of apprenticeship training.

### 10. Standard of Physical Fitness:

A candidate shall be eligible for being trained under the Apprentices Act, 1961 and the Apprenticeship Rules, 1992, as amended time to time, if he/she satisfies the minimum standards of physical fitness as prescribed therein for imparting training in the relevant discipline which will be certified by the Ordnance Factory Hospital, Ishapore.

After successful document verification of the provisionally selected candidates and on receipt of satisfactory Police Verification Report, medical examination will be conducted. Date, Time and Venue of medical examination will be conveyed separately. Candidates passed in medical examination will be considered for further process of engagement as Apprentices in this Factory.

# 11. Terms & Conditions:

- The selected candidates will have to execute a Contract of Apprenticeship (if minor, by his/her guardian).
- ii) Based on availability, the Apprentices may be provided with quarters/hostel accommodation on payment basis as per Govt. Rules.
- During the training, the Apprentices are entitled for medical treatment from Ordnance Factory Hospital, Ishapore as per rules.
- iv) If a candidate is selected as Apprentice, in Graduate/Diploma stream, his / her training shall be subject to registration in NATS web portal maintained by the Board of Practical Training (Eastern Region), Kolkata. If due to any reason the NATS portal is not able to register the candidate, the Apprenticeship Training of the candidate shall be terminated immediately.
- v) The candidate who have completed the period of training will be given Training Completion Certificate by Metal & Steel Factory, Ishapore.
- vi) In the event of premature termination of Contract of Apprenticeship Training for failure on the part of Apprentices to carry out the terms and conditions of the Contract (as notified under the Apprenticeship Rules, 1992 and amendments thereof), the candidate/surety has to pay/return such amount as is determined by Metal & Steel Factory, Ishapore as the cost of training.

# 12. Offer and acceptance of employment:

It shall not be obligatory on the part of the Employer to offer any employment to any Apprentice after completion of the training, nor shall it be obligatory for the Apprentices to accept any employment, if offered by the Employer. The candidate are advised to get themselves familiarized with the rules and regulations under the Apprentices Act, 1961, the Apprenticeship Rules, 1992 and amendments thereof and Rights of Persons with Disabilities Act, 2016.

# 13. Payment of Fees:

No fee shall be charged from the candidates applying for Graduate / Diploma Apprenticeship training.

#### 14. Mode of Selection:

- i. Selection will be based on the Merit List and vacancy positions as published in the advertisement.
- Final Merit Lists will be prepared considering reservation breakup, if any, in the descending order
  of percentage of marks obtained by the candidates in respect field in Graduate or Diploma Courses
  respectively.
- iii. Shortlisted candidates (as per vacancies position), thus enlisted, will be called for documents verification equal to number of notified vacancies.
- iv. In case of two candidates having the same marks, the candidates with older age shall be preferred. If the dates of birth are also same, then the candidate who passed respective Graduate or Diploma Examination earlier (Year) shall be considered first. Even if the years of passing of the respective Graduate or Diploma Examination are same, the candidate's name in alphabetical order appearing first will be considered first.
- v. Candidates finally enlisted in provisional select list would be subjected to satisfactory Police Verification Report including verification of educational qualification as well as requisite medical examination.

#### 15. Rejection of the candidature:

- c) If at any stage, the candidate is found over-age or under-age or Date of Birth not filled or wrongly filled.

- e) The candidature will be cancelled on applying for both Grade Apprentice and Diploma/Technician Apprentice.
- f) Application without photo, unclear photo, photo with cap, wearing goggles, disfigured, unrecognizable or unclear or unidentifiable photo.
- g) Application with unclear signature uploaded or documents submitted.
- h) Mismatch in candidate's name, father's name, Date of Birth, marks submitted and year of passing in online application form with the 10<sup>th</sup> Standard pass Certificate / Birth Certificate.
