Applications are invited for filling up of nine (09) posts of Technical Officer (Group 'A' Gazetted) in Level 11 of 7th CPC pay matrix in the Integrated Headquarters, Ministry of Defence (Navy) on deputation (including short term contract) basis. The eligibility conditions for applicants are as under:-

Deputation (Including Short Term Contract):-

Officers under the Central Government or States Government or Union Territories or Public Sector Undertakings or Recognized Research Institutions or Universities or Statutory or Autonomous Organizations:-

- (a)
 - (i) Holding analogous post on regular basis in the parent cadre or department; or
 - (ii) With five years of service in the grade rendered after appointment thereto on regular basis in level 10 in the pay matrix (Rs. 56100-177500) or equivalent in the parent cadre or department; and
- (b) Possessing the following educational qualification and experience:-
 - (i) Bachelors Degree in Mechanical or Electrical or Electronics and Communication or Marine or Naval Architecture or Industrial Engineering from a Recognized University or institute.
 - (ii) Five years working experience in relevant field of engineering out of which at least one year experience in Dockyard or Shipyard in Production, Planning, Control and Refit of Ships and Vessels.

Deputation or re-employment (for Ex-servicemen):

The Armed Forces Personnel of the rank of Lieutenant Commander (IN) or equivalent due to retire or who are to be transferred to reserve within a period of one year and having the requisite qualification and experience prescribed for deputation (including short term contract) shall also be considered. Such persons would be given deputation terms up to the date on which they are due for release from the Armed Forces; thereafter they may be continued on re-employment.

Note 1: The Departmental Officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short term contract) including period of deputation (including short term contract) in another Ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not to exceed four years.

Note 3: The maximum age-limit for appointment by deputation (including short term contract) shall be not exceeding fifty six years as on the closing date of the receipt of applications.

2. The terms and conditions of deputation will be governed by the DOP&T's OM No. DOPT-1667555503571 Estt.(Pay-II) dated 08.09.2022, as amended from time to time.
