Applications are invited for filling up of 01 (one) post of Deputy Chief Civil Hydrographic Officer (Group 'A') in Level-12 in the pay matrix (Rs. 78800-209200) in the Indian Navy (the vacancy is available at NHO, Dehradun) by Deputation (deputation including short term contract) basis from amongst the Officers of the Central Government or State Governments or Union Territory administration or recognized University or Institute or research Institutions or Public Sector Undertaking or statutory or Autonomous Organization: -

- (a) (i) Holding analogous posts on regular basis in the parent cadre or department;

Note 2: (Period of deputation (Including short term contract) including period of deputation (Including Short Term Contract) in another ex- cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed four years.

Note 3: The maximum age-limit for appointment by deputation Including Short Term Contract shall not be exceeding fifty-six years as on the closing date of receipt of applications.
