On behalf of the President of India, Commandant 160 Bn BSF will dispose off the unserviceable stores of Q Stores/Engg Branch/Comn branch/MT/Magazine by holding Public Auction at Bn HQ 160 Bn BSF, C A Wala, Jalalabad (Punjab) on **11<sup>th</sup> March 2024** from 1100 Hrs onward.

**2. Terms and Conditions:-**

- i) All the interested parties/bidders are requested to attend the auction at the given date & time along with their ID proof in original i.e. Aadhar Card, PAN Card, Voter ID Card and registration certification with GST Number of the firm.
- ii) Each bidder will have to deposit a sum of Rs. 15,000/- (Rupees fifteen thousand) only in cash as an advance as earnest money prior to the commencement of Auction which will be refunded/adjusted after completion of the Auction.
- iii) All the bidders must be in possession of their PAN card in original along with proof of last income Tax return which will be viewed by the detailed board of officers, failing which they will not be allowed to participate in the auction.
- iv) Auction money plus GST will be deposited on the spot by the successful bidders and stores must be collected from the site after completion of auction. In case final bidder fails to deposit the cost of the auctioned stores on the spot, earnest money deposited by him will be forfeited and shall be deposited into Govt Treasury.
