In this context refer to this office Memo no. 61137 dtd 09.11.23 & 6311 dtd 15.11.23 vide which you were directed to report at THQ, 40th Battalion, Dongargarh, Chhattisgarh- 491445, but despite issuing repeated reminders, you have not joined the duty yet. Subsequently apprehension roll under provision of I.T.B.P. Act 1992 under section 72 & 73 has also been issued to Superintendent of Police, District- Jalpaiguri (West Bengal) vide this office letter no. 6312 dated 15.11.2023. Apart from that, copy of above apprehension roll has also been sent to Police Station, Maynaguri, Distt.-Jalpaiguri(West Bengal). But, neither you have reported at THQ/BHQ, 40th Battalion, ITBP till date nor have been apprehended by civil police.
- 3. Apropos, under the provision of section 74 (i) of I.T.B.P. act 1992, Court of Inquiry (COI) has been ordered vide this office order No. 6488 dated 01.12.23 to find out the circumstances under which you absented from camp premises of Tac HQ, 40 Bn, ITBP. On the basis of recommendation of COI committee and under the provision of section 74 (ii) of I.T.B.P. act 1992 you have been declared "DESERTER" from the force w.e.f. 28.10.2023 (FN) vide 40th Battalion order No. 84-91 dated 06.01.2024.
- 4. In regard if you wish to submit a plea in your defence, make your physical presence before Comdt, 40 Bn, ITBP, Ranchi and submit in writing within 30 days of publication of this notification in News Paper else your services will be terminated taking ex-parte decision. Responsibility for such an action shall lie with you only.
