

DESPITE REPEATED CORRESPONDENCE/ REMINDERS, YOU HAVE NEITHER JOINED DUTY NOR SUBMITTED ANY EXPLANATION IN YOUR DEFENCE. A COURT OF INQUIRY WAS CONSTITUTED TO INQUIRE INTO THE CIRCUMSTANCES UNDER WHICH YOU WERE FOUND OVERSTAYING FROM LEAVE WITHOUT PRIOR PERMISSION OF COMPETENT AUTHORITY. ON THE RECOMMENDATION OF COI YOU HAVE BEEN DECLARED "DESERTER" FROM THE FORCE W.E.F. 12-11-2023 (AFTER NOON) VIDE THIS OFFICE ORDER NO.- 243-342 DATED- 04-01-2024 UNDER SECTION 74 (2) OF ITBPF ACT 1992. AS PER RULES, YOU HAVE BEEN GIVEN AMPLE OPPORTUNITY THROUGH VARIOUS CORRESPONDENCE APART FROM THE "SHOW CAUSE NOTICE" SENT BY REGISTERED POST ON 08-02-2024. AN ENQUIRY FROM NEARBY UNIT OF ITBP I.E., 52<sup>ST</sup> BN HAS BEEN MADE BY SENDING A REPRESENTATIVE AT YOUR HOUSE AND INFORMED THIS CENTRE THAT YOU WENT ABROAD (ENGLAND) WITHOUT PRIOR PERMISSION OF COMPETENT AUTHORITY WHICH IS IN VIOLATION OF PREVAILING INSTRUCTION. EVEN AFTER ELAPSE OF

04 MONTHS YOU HAVE NEITHER JOINED DUTY NOR MADE ANY CORRESPONDENCE TO THIS OFFICE REGARDING YOUR ABSENCE.

IF YOU FAILED TO REPORT TO DUTY WITHIN STIPULATED TIME I.E. WITHIN 30 DAYS FROM THE DATE OF PUBLICATION OF THIS NOTICE, THEN YOU SHALL BE DISMISSED FROM SERVICE AS PER PROVISIONS CONTAINED UNDER RULE 17 READ WITH RULE 20 OF ITBPF RULE 1994.
