

Regimental No. 080411267 Constable(GD) Srinivasa Reddy Kukkala, 'A' Coy, 41<sup>st</sup> Bn ITBP S/o Sh. Anki Reddy Kukkala, Address Vill.-Kukkalavari palem, PO/Tehsil/PS- Chinanaganjan, Distt:- Bapatla, State-Andhra Pradesh, Pin- 523135 is hereby informed that you were absented yourself from unit campus from 31.01.2024(AN) and continuously abesenting from duty without any prior permission of competent authority. Vide this office Memorandum No. 74-80 dtd 01.02.2024, 108-14 dtd. 06.02.2024 & 129-35 dtd 13.02.2024 you were directed to report back for duty immediately at BHQ, 41<sup>st</sup> Bn, I.T.B.P, but you have failed to do so till date. As per provision contained under section 72 & 73 of ITBPF Act-1992, apprehension roll was also issued to the Superintendent of Police, Distt- Prakasham (Now Bapatla) (Andhra Pradesh) vide this office letter No. 231-42 dtd 19.02.2024 to apprehended you and hand over to M.D.S. Almora I.T.B.P./41<sup>st</sup> Bn, I.T.B.P., but neither you were apprehended by the Police authority nor you have reported unit for duty.

Due to your continuous absence from duty w.e.f 31.01.2024(AN), a Court of inquiry (COI) was constituted by this office to inquire into the circumstances of your prolonged absence vide this office order No. 706 dtd 04.03.2024 in term of Section 74 (1) of ITBPF Act- 1992. On the basis of the findings and recommendations of COI, you have been declared "Deserter" w.e.f. 31.01.2024(AN) vide this 41 Bn. order No. 1371-87 dtd 12.03.2024 in term of section 74 (2) of ITBPF Act-1992. A copy of the deserter order was also sent through registered letter to your home address. Apart from above, you were also issued a "Show Cause Notice" vide this office letter No.1633 dtd. 27.03.2024

Anki Reddy Kukkala is hereby again directed that you must report for duty at 41<sup>st</sup> Bn ITBP, Vikram Nagar camp, Tartua, Odisha within 30 days from the publication of this notice in News paper or you may submit documents in your defense, failing which, it will be presumed that you have nothing to say on the matter and thereafter, necessary orders will be issued.
