## Show cause notice

As you are aware that on your own request you were sanctioned 15 days casual leave from 07.09.23 to 26.09.2023. After the end of leave, you were supposed to report at the transit camp Jammu on 26.09.2023 (AN) but you are absent from 27.09.2023 (FN) without the permission of the competent authority and leave approval.

- 2. To find out the reasons for your absence from 27.09.2023 (FN), A court of inquiry committee constituted under the provisions contained in Section 74 (1) of the ITBP Force Act-1992, vide 21<sup>st</sup> Bn's office order 3247 dated 23.12.2023.
- 3. In the said case, you were directed under the 21st Bn's Registered Office Memorandum No. 5670-70 dated 06.10.2023, Office Memorandum No. 5961-65 dated 23.10.2023 and letter number 6446-57 dated 10.11.2023 that you should immediately report to the 21st Bn, ITBP Force, Pantha Chowk, Srinagar (Jammu and Kashmir) otherwise action will be taken against you under ITBP Force Act 1992 and Rules 1994 but you did not report your arrival at BHQ. You have clearly disregarded the orders of this office. Under this letter 6446-57 Dtd 10.11.2023, the DM of your home district, Senior Superintendent of Police and nearest police station In-charge were requested to arrest you and hand over to BHQ/ Formation of ITBPF, but neither local police caught and handed over nor did you give your present in BHQ.
- 4. Your non-joining the Battalion despite correspondence from the Battalion shows that you are not willing to serve in the Indo-Tibetan Border Police Force and in view of the facts compiled by the Court of Inquiry Committee and the irresponsible behavior displayed by you, on the basis of the opinion and recommendation of the court of inquiry committee constituted under the provisions contained in Section 74 (1) of the Indo Act 1992, vide this office order number 390-401 dated27.09.2023 you have been declared "Deserter from the Force" wef 27.09.2023(FN), a copy of which has been sent to your home town address through registered post.
