Page yadav sita ram, Village-Mulane, Post-Mavdi, P.S.-Vani, Teh-Dindori, Distt-Nashik, State-Maharashtra, Pin-422215 was sent Composite hospital, Chandigarh on 13.03.2024 for attender duty of Regt. No. 910100391 ASI(GD) Hargovind Singh. From where the personnel was sent to the transit camp chandigarh on 18.03.2024 and the personnel is absent from the transit camp chandigarh w.e.f. 19.03.2024(AN) without the permission of the competent authority.

2. transit camp chandigarh e-mail msg no. 1393 dtd. 19.03.2024 The absence report of the personnel was sent to 16th Bn. After which Central Record Office, ITBP has been requested to stop your pay and allowances vide 16th BN ITBP e-mail No. 21523 Dtd-23.03.2024. The personnel was also directed to join duty immediately vide 16th BN ITBP letter no. 3102-05 dtd. 23.03.2024.

3. Due to the personnel absence from the transit camp chandigarh the information was sent to the personnel wife Smt. Page pooja arun yadav reg. the personnel absence from the transit camp chandigarh. You was directed to immediately join the 16th BN ITBP vide this office memo no. 3389-92 dtd. 02.04.2024, the information of which was also given to your Next of Kin Smt. Page pooja arun (wife), But neither you have reported in this unit nor any information sent to this unit regarding your absence.

4. Further, Superintendent of Police, Distt-Nashik (Maharashtra) was also requested to apprehend you and handover to 16th Bn ITBP vide this office letter no. 499-503 Dtd-18.04.2024, the information of which was also given to your next of kin. But neither you were apprehended and handed over to this unit by the concerned District administration nor any information sent to this office and you also have not reported in this unit till date.

5. In view of your absence from transit camp chandigarh without permission of the competent authority and provisions contained under section 74(1) of the ITBPF Act-1992 a Court of Inquiry was constituted vide this office order No. 3857-60 dtd-01.05.2024 to inquire into the circumstances under which you are absenting from transit camp chandigarh. Keeping in view the findings, opinion and recommendation of Court of Inquiry and the available evidences, you have been declared "**Deserter**" vide this office Order No. 3149-64 Dtd-29.05.2024 under section 74(2) of ITBP Act 1992 with effect from the date of your absence from leave i.e. 19.03.2024(AN).
