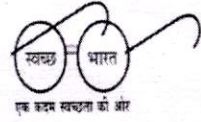

Arunpal Singh, Resident of Vill-Pawan senatory wali gali, Tej Vihar Rohta Road, PO-Meerut, P.S.-Meerut, Distt-Meerut (Uttar Pradesh), Pin code-250001, is hereby informed that you were sent for 15 days casual leave w.e.f. 08.06.2024 to 26.06.2024 with permission to avail sunday on 09.06.2024, 16.06.2024 & 23.06.2024 and GH on 17.06.2024. After expiry of leave on 26.06.2024 (AN), you had to report back at BHQ 3<sup>rd</sup> Bn, ITBP on 26.06.2024 (AN) but you are continuously absenting yourself w.e.f. 26.06.2024 (AN) without any sanctioned leave/prior permission of the competent authority. You have been repeatedly directed by this office to report on duty but you have failed to do so and did not report till date. As per the provisions contained under section 74 (2) of ITBPF Act-1992, you have been declared "DESERTER" w.e.f. 26.06.2024 (AN) vide this office order no. 5280 dated 04.09.2024 and copy of the same has also been sent to you on your permanent address by registered/speed post.

2. On going through your case documents, the undersigned has come to the conclusion that you are not willing to serve in the force and hence why not you may be "Removed from service" as per powers conferred to undersigned under rule 17 & 20 of ITBP Rule 1994 on ground of unsuitability. If you have anything to say against this decision, you can appear within 30 days from the date of issue of this notice and represent in writing. After expiry of prescribed time limit, it will be presumed that you have nothing to say on this and you will be "REMOVED FROM SERVICE" by the competent authority, without further correspondence.
