Show Cause Notice

Regimental No. 090360301 Constable(GD) Vikash Kumar joined 5th Bn, ITBPF on 20.07.2024 on permanent transfer from 18th Bn, ITBPF. After joining the 5th Bn, personnel was posted in 'D' Coy. The employee requested to go on leave for his mother's treatment. Subsequently, the employee was sanctioned casual leave for 14 days from 25.07.24 to 09.08.24. After the end of leave, the employee was supposed to give his arrival at the transit camp Chhawla on 09.08.2024 (AN), but by not giving his arrival at the transit camp Chhawala, the employee remained absent without the prior permission of any competent authority. Transit Camp Chhawala vide their e-mail message no. 1106 dated 10-08-24 intimated this office about the personnel absence. DIG, CRO was requested to stop pay and allowances of the personnel vide 5th Bn e-mail message no. 20420 dated 13.08.24.

- 2. The personnel was directed to join the Battalion Headquarter immediately vide 5th Bn Office memorandum No. 5630 dated 14.08.24, memorandum no. 1759 dated 29.08.24 and memorandum no. 7065 dated 11.09.24, but the personnel did not give any response to the letters sent by this office.
- 3. On non-arrival of the personnel at Battalion, the Superintendent of Police, District-Bhojpur Ara (Bihar) and SHQ, Police Station- Mufesil Ara (Bihar) were requested vide 5th Bn letter no. 795-97 dated 13-09-24 to apprehend the personnel and handover to 5th Bn, ITBP Force, but the concerned Police department neither apprehend and handover the personnel nor any information was provided to this office.
- 4. To inquire into the circumstances for the personnel absence from 09-08-24 without the permission and information of any competent authority, a Court of Inquiry was constituted vide 5th Bn order No. 1943 dated 25.09.24 under the provision contained in Section 74(1) of the ITBP Force Act, 1992.
- 5. On the basis of the recommendation and report of Court of Inquiry Committee and as per provision contained in Section 74 (2) of ITBPF, Act 1992, the personnel has been declared as '**DESERTER**' w.e.f. 10.08.2024(FN) vide 5th Bn order No. 8304 dated 01.11.24 and a copy of the deserter order has been sent to the personnel home address by registered post.
- 6. Even after lapse of considerable time, the personnel has still not report at 5th Bn; ITBP Force, Leh (UT). Therefore, through this Notice, the personnel is given this last opportunity to report at 5th Bn, ITBPF (Leh) within **30 days** of the publication of this Show Cause Notice in the Newspapers, failing which it will be presumed that the personnel is not interested to serve further in I.T.B.P. Force and **services of the personnel will be terminated** as per provision contained in ITBPF, Act 1992 and Rules, 1994.
