"Show Cause Notice"

You, Smt. Ramasani Sailaja, D/o Shri Ramasani Thimma Reddy, Resident of H.No. LIG 297, APHB Colony, Ananthapur-515001, Andhra Pradesh, working as Engineering Assistant in the office of Doordarshan Kendra, Warangal (Telangana State)(under the Cluster Administration of Doordarshan Kendra, Hyderabad), was absent herself unauthorized w.e.f. 01/01/2006 to till date. You were directed vide Memoranda dated 04/01/2006, 20/01/2006, 27/06/2006, 25/09/2006 to join duty immediately but no response was received from your end.

You, Smt. Ramasani Sailaja, D/o Shri Ramasani Thimma Reddy, have obtained "Passport" by producing false information to the Passport Authorities and usual procedure was not followed to obtain the Passport.

Further, you mentioned in all your leave applications that you applied for leave to take care of ill-health parents. You have not intimated this office that your parents are dependent on you.

Whereas, it was informed to you vide show-cause notice issued under letter No. DDKW/7(3)/2007-Admin/765 dated 01/03/2007 that disciplinary action shall be initiated against you for the said mentioned lapses and with instructions to report for duty by 19/03/2007. AND consequent upon non-joining by you at your duty place by the stipulated date, the disciplinary authority have constituted an inquiry against you vide Order No. DDK/WGL/7(3)/2007/Admin/ dated 20/06/2007 for willful and unauthorized absence from duty without any information.

Whereas, it has been reported by the Inquiry Officer vide Inquiry Note dated 28/02/2008 that you remained absent from the entire proceedings of the inquiry due to which inquiry could not be conducted as per the procedure. The opportunity in your defense to be heard was given to you by the Inquiry Officer vide her letters dated 26/07/2007, 04/09/2007, 29/11/2007, 17/01/2008 but you failed to appear before the Inquiry Officer.

Whereas, the Disciplinary Authority in exercise of the powers conferred upon under CCS (CCA) Rules, 1965 has decided to give you a last chance to join your duty and appear before the Inquiry Officer or the disciplinary authority in your defense, within 30 days after the publication of this show cause notice, failing which ex-parte decision will be taken and you will be terminated/dismissed from service.
