## 1. Executive (SIIS-Operations) – 02 Posts

**Qualification:** BE / B Tech with at least 60% marks from recognized University/ Institution.

**Experience Requirement:** Minimum 02 years of post-qualification experience in control room of a power station or central control room of a power company of minimum 1000 MW installed capacity.

**Job Profile:** Compilation of stations performance and preparation of daily performance sheet of NTPC group. Preparation of daily morning performance report of NTPC Group stations. Monitoring of Fuel Receipt, Stock and Consumption in NTPC and JV Stations. Monitoring and reporting of tripping/ Synchronization of Units and any other major events at stations through messaging, phone, or update in software. Daily Gas allocation and consumption details for Gas stations of NTPC. Monitoring of daily block-wise Declared Capability, schedules, ramp rates etc for each Stages/Stations. Monitoring of real time generation of NTPC stations. Entering data of JV Stations, PSP reports, Solar data in SIIS database and generating reports thereof. Monitoring of All India Demand, Generation from various sources, Frequency and any other major event affecting the grid. Any other work, as per instructions by the management. Required to work in Shifts (including night shift).

## 2. Executive (SIIS-Tech) – 02 Posts

**Qualification:** BE/B Tech/BSc/M-Tech in Computer Science/IT/Electronics or MCA with at least 60% marks from recognized University/ Institution.

**Experience Requirement:** Minimum 02 years of post-qualification experience in the area of SQL Server, SAP, OSISoft PI, C#, Python and Web report development. Candidates having experience in power generation/industry will be preferred.

**Job Profile:** Capturing data related to power sector from various Govt/Private organizations websites and storing the same in NTPC database. Developing web reports, alarms, manual data entry forms etc. Maintain OS SIIS database and websites. Perform All India vs NTPC Comparisons. Analysis of all India demand vs NTPC Group performance vis-a-vis other IPP's/State performance. Any other work, as per instructions by the management.

**Upper Age Limit for both the posts:** 35 years

**Remunerations for both the posts:** Monthly Consolidated amount Rs. 100000/-. Additionally, Company accommodation/HRA, Night shift entertainment allowance (if rostered in shift), Medical facility for self, spouse and two children.

## GENERAL CONDITIONS:

1. Only Indian Nationals are eligible to apply.
2. All qualifications should be from Universities / Institutions recognized and approved in India.
3. All computations of age/ experience requirement / qualification shall be done w.r.t. the last date of receipt of online as mentioned in the advertisement.

4. Candidates claiming to belong to any particular category shall necessarily have a valid EWS/OBC/SC/ST/Disability certificate, as the case may be, from the Competent Authority. Where there is vacancy identified for such category, upper age limit is relaxed by 5 years for SC/ST candidates, by 3 years for OBC candidates, by 10 years for PwBD candidates. Relaxation of age to Ex-Serviceman as per Govt. guidelines.

5. In-order to restrict the number of candidates to be called for an interview, if so required, the Management reserves the right to conduct online screening/shortlisting/selection test or to raise the minimum eligibility standards/ criteria, as per requirement.

6. Depending on the requirement, the Company reserves the right to cancel / restrict / curtail / enlarge the number of vacancies, if need so arises, without any further notice and without assigning any reason thereof.

7. Posting shall be at any of the Stations/ Projects/ JVs/ Subsidiaries of NTPC. All posts are transferable at the sole discretion of the Management.

While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above, as on the specified dates and that the particulars furnished are correct in all respects. Candidate belonging to General/EWS/OBC category are required to pay a non-refundable application fee of Rs. 300/-. The SC/ST/PwBD/XSM category & female candidates need not pay the application fee.

**Payment in offline mode:** State Bank of India has been authorized to collect the application fee, in a specially opened account (A/C No. 30987919993) at CAG branch, New Delhi (Code: 09996), on behalf of NTPC. Candidate has to approach the nearby SBI branch with a printout of the "pay-in-slip" which is available on the application portal. The pay-in-slip printed from the portal should only be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the bank will issue a unique Journal Number and a Branch Code of the bank collecting the money. This journal number and the branch code are to be filled up by the candidate during online application. NTPC will not be responsible, in case a candidate deposits the fee in wrong account.

**Payment in online mode:** Candidates also have the option to pay the fees online (through Net banking / Debit Card (Rupay debit cards Only) / Credit Card). The online payment option will be available in the online application form.
