NOTIFICATION


You, No. 090110055 CT(GD) Yadav Chetry of SHQ(Lucknow), I.T.B.Police, PO-Jaitikhera, Teh Sarojini Nagar, Distt-Lucknow (U.P.)-226301 is absenting himself from leave w.e.f. 12.11.23(FN without prior permission of competent authority, which is an offence under Section 21(b) & 43 of I.T.B.Police Act 1992.

2. In this context refer to this office Memo No. 5195 dtd. 13.11.23, No. 5232-33 dtd. 20.11.23 and No. 5304 dtd. 29.11.23, vide which you were directed to report at SHQ(Lucknow), I.T.B.Police PO-Jaitikhera, Teh-Sarojini Nagar, Distt-Lucknow (U.P.)-226301, but despite of repeated reminder you did not join the duty. After that apprehension roll under provision of I.T.B.Police Act 1992 under section 72 & 73 had been issued to Senior Superintendent of police, Distt-Sonitpur (Assam) vide SHQ(Lucknow), I.T.B.Police vide Letter No. 5359-66 dated 15.12.23 under intimation to Superintendent of police, Distt-Sonitpur (Assam) & SHO Police Station, Rangapara, Distt-Sonitpur (Assam), but neither you reported at SHQ(Lucknow) PO-Jaitikhera, Teh-Sarojini Nagar, Distt-Lucknow (U.P.)-226301 till date nor apprehended by Civil Police.

3. Under the provision of Section 74(i) of ITB Police Act 1992, Court of Inquiry (COI) has been ordered vide this office Order No. 5522 Dtd. 28.12.23, to find out the circumstances under which you are absented from leave. On the basis of recommendation of COI committee and under the provision of section 74(ii) of ITBP act 1992 you have been declared "DESERTER" from the force w.e.f. 12.11.23(FN) vide SHQ(Lucknow), I.T.B.Police Order No. 836-45 dated 19.02.24.

4. You are hereby informed through this notice to submit your plea, if any, in your defence to the undersigned within 30 days from the date of publication of this notification in newspaper, otherwise ex-parte decision will be taken in the case and you will be dismissed from the service without further correspondence. Responsibility for such an action shall lie with you only.
