## Section I : Technical Brief

Central Bureau of Communication, Regional Office, Bhubaneswar organizes Exhibitions in **different districts all over Odisha** for the Ministry of Information & Broadcasting and other various client Ministries/Departments. To organize the exhibitions, CBC, RO, Bhubaneswar requires various items and materials for execution of the job. List of the items and materials required for the exhibitions are as follow:

*German Hangar structure with wooden platform (AC/ Non AC), Tin Structure with wooden platform and false ceiling, water proof tent, generator, furniture (table, chair, centre round table, sofa set, carpet, crockery), lighting, setting of pagoda (AC/Non AC), VIP Toilet, stage for cultural programme, erection of chandni ( False Ceiling & side wall).*

## Section II: Eligibility Criteria

### **The Agency/Firm/Company-**

- (a) Must be in the business of supply of items (mentioned at Section I) in the exhibitions of Union/ State Govt. for a minimum period of three years and must be able to provide all the items and services.
- (b) Must have the average annual turnover of not less than **Rs. 50, 00,000/- each year** during the last two financial year. The applicant agency/firm/company must submit turnover certificate (consolidated) for the last 2 financial year certified by the Chartered Accountant (CA) along with the copies of the balance sheet, profit/loss statement of last two financial years, Pan No. and GST No.
- (c) Must be an Indian entity or must be an Indian agency/firm/company having tie-up with an international agency/firm/company or must be a wholly owned Indian subsidiary of an international agency/firm/company registered in India.
- (d) Agency/firm/company must submit the detailed profile (Name, Address, Phone No. etc. and work profile) of the manpower (technical and skilled-unskilled) engaged by the agency/firm/company. The application must contain the Agency/firm/company profile along with the details of key professionals like names, addresses, sample designs etc.
- (e) Copy of the work orders/job orders, appreciation and award certificate pertaining to work accomplished by the agency/firm/company in the last three financial years.
- (f) All the documents submitted by the agency/firm/company must be self attested with company seal.

### Section III : Selection Procedure

#### (i) Technical and Financial bids:

(a) CBC,RO,BBSR will evaluate the technical proposals submitted by the respondents through a detailed scrutiny. During evaluation of proposals, CBC, RO may at its discretion ask the respondents for clarification w.r.t. any point submitted in their proposals. The technical bid will be evaluated by a committee constituted for the purpose. Technical specifications on the basis of which any agency/firm/company will be evaluated are mentioned at **Annexure-I** and **Section-II**.

(b) Financial bid of only “Technically Qualified” bidders shall be opened. The bidders must quote rates for the exhibition items, as specified in the ‘**Proforma for Financial Bid for German Hanger Structure etc.**’, on their official letter head signed by the authorized signatory. The quoted rate should be exclusive of applicable taxes which will be paid by CBC, RO,BBSR at the applicable rates from time to time.

#### (ii) Submission of proposals by respondents:

(a) Technical and Financial proposals must be submitted together but in separate envelopes each properly sealed and labeled. The envelopes for Technical and Financial Bids must be separately super scribed “**Technical bid for hiring of German hanger structure etc. for the exhibitions**” and “**Financial Bid for hiring of German hanger structure etc. for the exhibitions**” respectively. The bidder should put these two sealed envelopes in a bigger envelopes duly sealed and labeled “**Quotation for hiring of German hanger structure etc. for the exhibitions**”.

(b) The envelopes must be submitted in the name and address as mentioned in the data sheet above. The envelopes must indicate the name and address of the agency and should be properly sealed and labeled. In case the envelopes are not sealed and labeled, CBC,RO, Bhubaneswar shall assume no responsibility for the misplacement or premature opening of the proposals.

#### (iii) Award of Contract:

(a) **Technical Bid:** The technical proposals of agencies will be evaluated by the committee constituted for the purpose based on criteria mentioned in the **Section II**. The number of agencies which are found to be technically qualified will be intimated telephonically.

(b) **Financial Bid:** Financial bid of only those agencies will be opened which have been found to be technically qualified. The following criteria will be used to determine L-1 rates for the items mentioned in the “**Proforma for financial bids for German hanger structure etc.**”

(i) The lowest rate in each of the items, as mentioned in Annexure-II (Titled: Proforma for financial bid for German Hanger structure items) would be considered as L-1. In case agency/firm/company which has quoted L1 rates is unable to satisfactorily perform the job due to excess amount of workload or non performance, then the agency/firm/company which has quoted the L2 rates will be considered for the job on the basis of L1 rates coined for the particular items. If the selected agency/firm/company fails to deliver the work assigned to agency, CBC, RO,BBSR may de-empanel it and choose the replacement. Failing to execute the job order assigned by CBC, RO,BBSR on two occasions within a period of six months for any reasons whatsoever will result in suspension from the panel of CBC, RO,BBSR for a period as decided by ADG, CBC, RO, Bhubaneswar

## Section IV: Terms and Conditions

1. Partial acceptance in one or two items will disqualify the agency/firm/company from the selection/tender process.
2. The empanelment of agency/firm/company shall be valid for one year from the date of issue of letter of empanelment. Empanelment may be further extended by another year subject to satisfactory performance of the agency/firm/company after the approval of ADG,CBC, Regional Office, M/o I&B, Govt. of India, Bhubaneswar.
3. CBC, RO, BBSR reserves the right to utilize the services of any of the agency/firm/company qualified for the financial bid. The empanelment does not guarantee any business from CBC, RO, BBSR.
4. If the selected agency/firm/company fails to deliver the work assigned to them, CBC, RO may de-empanel it and choose the replacement. Failing to execute the job order assigned by CBC, RO, BBSR on two occasions within a period of six months for any reasons whatsoever will result in suspension from the panel of CBC, RO,BBSR for a period as decided by ADG, CBC, RO,BBSR.
5. The bidder shall bear all costs associated with the preparation and submission of its bid and CBC, RO, Bhubaneswar will, in no way, be held responsible or liable for these costs, regardless of the selection or rejection of the bidder due to any reason whatsoever. It is also clarified that no bidding relationship shall exist between any of the respondents and CBC, RO until execution of a contractual agreement.
6. The bidder is expected to examine all instructions, statements, forms, terms and specifications in the bidding documents. Failure to furnish the necessary documents/ information may lead to rejection of bid. Conditional bids will be summarily rejected.
7. No consideration shall be given to a bid received after the date and time stipulated by CBC, RO, BBSR. However, CBC, RO, BBSR reserves the right to extend the time for submission of the bids at its own discretion.
8. To assist in Technical evaluation, CBC,RO,BBSR reserves the right to call for any clarification from any/all bidder/agency during the course of evaluation of the bids. The agency/firm/company may be asked to submit their clarification in writing or the agencies may be called for a presentation to the technical committee constituted by CBC, RO, BBSR for the purpose.
9. Overwriting/corrections in the financial bid are not permitted and any such overwriting in the financial bid shall lead to its rejection.
10. Participation in this bid shall imply that the bidder has accepted all the terms and conditions and subsequent modifications, if any, of this bid documents.
11. At any future point of time, if it is found that the bidder has made a statement which is factually incorrect or misleading or if the bidder does not fulfill any of the contractual

obligations, CBC, RO, BBSR may debar the bidder from bidding prospectively for a period to be decided by CBC, RO, BBSR and take any other action as deemed necessary.

12. The agency/firm/company applying for empanelment shall submit an undertaking in the form of a self certificate that the information submitted by them is correct and they shall abide by the decision of CBC, RO, BBSR in respect of empanelment. In case the information submitted by the agency/firm/company is found to be false and/or incorrect in any manner, the agency shall be suspended and / or debarred.

13. Notwithstanding any of the provision mentioned above for empanelment of agency/firm/company and their terms and conditions, in case of any disagreement etc. decision of CBC, RO, BBSR will be final and binding.

14. Once an agency/firm/company is offered rates as mentioned in **Section III (iii) (b) (i)**, the bidder has to accept rates.

15. CBC, RO, BBSR reserves the right to cancel the entire tender process at any stage without assigning any reason thereof.

**16. A copy of this quotation document duly signed and stamped on every page shall be submitted with the bid documents as a mark of acceptance of terms and conditions mentioned therein.**

17. Agency/firm/company will undertake in writing that CBC,RO, BBSR approved rates accepted by them are their lowest rates and exclusive to CBC and cannot be offered to any other agency. CBC, RO, BBSR reserves the right to review rates if this condition is violated.

#### **18. Payment Terms:**

- (a) The agency/firm/company MUST submit a consolidated bill to CBC, RO, BBSR after the completion of the exhibition work, which was performed as per the CBC, RO, BBSR directions and job order for a particular exhibition.
- (b) **The agency/firm/company shall charge CBC, RO, BBSR as per the accepted rates per items.**
- (c) CBC, RO, BBSR shall pay applicable taxes to the agency as charged in the bill.
- (d) No advance payment will be made to the agency/firm/company.
- (e) 100 % of the total contract value shall be released only after satisfactory completion of the job assigned to the agency/firm/company.
- (f) CBC, RO, BBSR shall not be held liable for any default of payment by the agency/firm/company to other party, manpower involved or engaged by it for the completion of the job.
- (g) CBC, RO, BBSR will not bear any additional cost for the work assigned to the agency/firm/company for any work that at the agency may have to undertake in course of the project beyond agreed amount as per tender.
- (h) In case of default of any kind including failure to fulfill the terms and conditions of the job order CBC, RO, BBSR can reduce the amount as per the admissible rule.
- (i) Rate must be quoted in all respects including erecting, dismantling, transportation at exhibition site and Coolie charges etc. GST must be mentioned separately.
- (j) Income Tax and GST will be deducted at source at the time of payment as per rule.

## **19. Penalty Clause:**

(a) No payment shall be made by the CBC, RO, BBSR to the agency/firm/company, if agency/firm/company fails to deliver the items as per the requirements of the CBC, RO, BBSR.

20. Agency/firm/company must carry out modification/alteration in the designs as per the requirement of CBC, RO, BBSR. For any modification and alteration in design no extra payment will be made by the CBC, RO, BBSR.

21. Officials of CBC, RO, BBSR can inspect the business premises/workshops of the agency/firm/company at any point of time, if required.

22. Time and quality will be the essence of the contract. If agency is found unsuitable (i.e. delayed execution/poor workmanship) the contract can be cancelled at any point of time without assigning any reason and certain percentage of amount can be deducted as recommended by reviewing committee as thereof.

23. Nominated officers of CBC, RO, BBSR will inspect the quality of job, materials and items. Decision of competent authority of CBC, RO, BBSR in this regard will be final and binding on the firms.

24. All electronic/electrical items should be in working condition during exhibition hours. Operation/maintenance in all respects will be the sole responsibility of the agency/firm/company. Any disorder in the electronic equipment/electrical items during the exhibition hour will invite deduction of amount.

25. Any accident/mishap during the execution of the job will be the sole responsibility of the concerned agency/firm/company, who is assigned the job.

26. All contracts shall contain a provision for recovery of liquidated damages for defaults on the part of the contractor.

27. All rights are reserved with CBC, RO, BBSR to reject the services/goods/items which do not conform to the specifications.

28. Failure to meet the deadline, schedule & quality may impose a penalty as per the provisions of GFR.

29. One official/officer in charge/coordinator from the agency must be available for entire period of the exhibition to resolve the issues pertaining to exhibitions.

30. Decision of the ADG, CBC, RO, Bhubaneswar in all matters with regard to this tender will be final and binding on all the bidders those have participated in this bid.

## **GENERAL TERMS OF TENDER:**

1. The job must be executed as specified in the work order / job order issued by Addl. Director General, CBC, RO, BBSR who shall be the sole assessor of the job executed by the agency/firm/company. If the execution of job is not in accordance with the specifications as directed by the Addl. Director General, CBC, RO, BBSR the items are liable to be rejected without any compensation to the agency/firm/company. The Addl. Director General can summon the agency/firm/company to rectify the error(s) and defect(s) within the time period fixed by the Addl. Director General. The decision of the Addl. Director General in this regard shall be final and binding on the agency/firm/company. The Government shall be under no liability for rejected supplies and items. If the rejected supplies/items are not removed by the agency/firm/company after the rejection, the Addl. Director General may (a) cause those to be removed and charge the agency/firm/company with all expenses incurred in such removal or (b) shall or otherwise dispose of them on behalf of the agency/firm/company at their risk and cost and retain any money realized there from (after paying expenses of sale) towards any sum due from the agency/firm/company.
2. The time specified for delivery of items/material or completion of the order shall be strictly adhered to and deemed to be the essence of the contract. If the time schedule is not adhered to and the job is delayed at the time of sending items or during production or dispatching for reasons other than beyond the control of the agency/firm/company, the Addl. Director General shall be entitled to exercise the options (a) to cancel the order (b) to recover from the firm/agency as agreed liquidated damages and not by way of penalty amount up to 20% of the contract price for the delay. The decision of the Addl. Director General as to whether the delay was or was not beyond the control of the agency/firm/company and as to the amount of liquidated damages to be recovered from the agency/firm/company shall be final and binding on the agency/firm/company. In the event of action to be taken under (a) above the cancellation of the order will be without prejudiced to the right of the Govt. to recover from the agency/firm/company any loss incurred thereby and the agency/firm/company will not be entitled for any compensation for such cancellation.
3. The agency/firm/company shall take every step to ensure that work or any portion thereof does not fall into unauthorized hands. All specimens and trial and spare copies must be destroyed in the presence of one responsible representative of the firm/agency or govt. representative. A certificate that these precautions were taken shall be sent to the Addl. Director General after the completion of the work.
4. All Artworks etc. which have been supplied by the Govt. or which have been prepared by the agency/firm/company for the Govt. must be stored by the agency/firm/company until such time it may be called upon by the ADG, CBC, RO, BBSR to return the same.
5. In the event of (i) rejection of specimen of bulk supply (ii) supplier failing, declining, neglecting or delaying to comply with any demand or requisition or otherwise not executing the job in accordance with the terms of the contract, the ADG, CBC, RO, BBSR shall be at liberty (without prejudice to any remedy the Govt. may have on account of any claim for compensations against loss and inconvenience caused by such breach or non performance of the contract) to purchase, or to procure or to arrange from Govt. stock or otherwise at agency/firm/company expenses such supplies as may have been rejected or that the



agency/firm/company may have failed, declined or neglected or delayed to supply and any excess cost so incurred over the contract price (together with all incidental charges and expenses insured in purchasing, procuring or organizing for such supplies/services) and in case where issuing in replacement are made from Govt. stocks, the cost of value of such stocks together with all incidental charges or expenses shall be recoverable from the firm/agency. The firm/agency shall not however, be entitled to any gains or result of the work being done as aforesaid against his default.

6. The ADG, CBC, RO, Bhubaneswar may rescind the contract by notice in writing,

(i) If the agency/firm/company assign or sublet the contract.

(ii) If the agency/firm/company or their agents shall (a) be found guilty of fraud by in respect of the contract or any other contract entered into by them with the Govt. or (b) directly or indirectly give, promise or offer any bribe, gratuity, gift, loan, perquisites or advantage pecuniary or otherwise to any officer or person in the employment of the Govt. in any relating to such officers or persons officer or employment.

(iii) If the agency/firm/company decline, neglect or delay to comply with any demand or requisition or in any other way fail to perform or observe any condition of this contract.

(iv) If the agency/firm/company becomes insolvent or apply for relief as insolvent debtor or commence any insolvency proceeding or make any compensation with their creditors or attempt to do or in case of the suppliers being registered company any order be duly made or any resolution be duly passed for the winding up of the company.

In these cases of such recession the security deposit shall stand forfeited to the Govt. and be absolutely at the disposal of the Govt. without prejudice to any other remedy that the Govt. may have.

7. If any time after the acceptance of the tender, the Govt. shall for any reason whatsoever not required the whole or part of the job to be carried out the ADG, CBC, RO, BBSR shall give notice in writing of this fact to the firm/agency who shall have no claim to any payment or compensation or otherwise, however, on account of any profit or advantage which he might have derived from the execution of the job in full but which he did not derive IN CONSEQUENCE OF THE FORE CLOSING THEREOF. In such a foreclosure is done before the supplier has commenced the work, he will not be entitled to any compensation whatsoever. If, however, the firm/agency has commenced the work before such fore closure the ADG, CBC, RO, BBSR shall decide what sum shall be paid to the firm/agency as charges or compensation for the work already done and her decisions in this behalf shall be final and binding on firm/agency.

8. If during the currency of the contract the specification of any articles/ design to be supplied to be changed, the firm/agency shall continue to supply the same article or articles in accordance with the new specification at a rate to be decided by the ADG, CBC, RO, Bhubaneswar.

9. A person signing the tender form or any document forming part of the contract on behalf of the another shall be deemed to warrant that he has authority to bind such other and if on enquiry, it appears that the person so signing has no authority to do so, the ADG, CBC, RO,

Bhubaneswar may without prejudice to other civil and criminal remedies, cancel the contract and hold the signature liable for all costs and damages.

10. The quotation shall hold good for a period of six months from the last date fixed for its submission.

11. Sales Tax and other duties: Firm / Agency should quote net rate including all taxes.

12. Security Deposit: The Agency / Firm / Company whose quotation is accepted shall within the period specified in the acceptance letter furnished to the ADG, CBC, RO, BBSR submit Security Deposit for the amount demanded by the ADG, CBC, RO, BBSR. The security shall be in such form as may be specified by the CBC, RO, Bhubaneswar. Unless the ADG, CBC, RO, Bhubaneswar extends the time limit for the submission of the security, the failure of a firm/agency to furnish the security deposit within the specified period shall be entitled to make other arrangements for procuring the material agreed to be supplied under the contract at the risk and expense of the firm/agency.

13. CBC, RO, Bhubaneswar shall not be responsible for any loss of securities or for any depreciation in the value of securities while in their charges or for loss of any interest thereof. In the case of Bank deposit receipt, the Govt. shall not be responsible for the loss that may result on account of the failure of the bank.

14. Refund of security deposit: On the performance and completion of the contract in all respect and on return in good condition of any art work sample as or other property belonging to ADG, CBC, RO, Bhubaneswar which may have been issued to the agency, the security deposit if not already forfeited, will be returned to the agency.

15. Recovery from the Agency: Wherever under the contract any sum of money shall be recoverable from or payable by the agency, unless he pay the same on demand, the Govt. shall be at liberty to deduct the same from any sum then due or which at any time thereafter may become due to the firm/agency under the contract or under any other contract with the Govt. or from his security deposit.

16. The Govt. reserves the right to carry out a post payment audit of the firm/agency's bills including all supporting vouchers. The Govt. further reserves the right as a result of such a check by any or all of the methods prescribed above.

17. The ADG, CBC, RO, Bhubaneswar may authorize such officers as he/she may wish to operate the contract on behalf of the Govt. and the firm/agency will accept and carry out instructions given by such officers in connection with the contract as it these were issued by the ADG, CBC, RO, BBSR.

18. The ADG, CBC, RO, Bhubaneswar has the power to accept or reject any tender without assigning any reason, therefore and is not bound to accept the lowest or any tender.
