#### Notification

G.S.R. 2---. In exercise of the power conferred by the proviso to article 309 of the constitution and in supersession of (erstwhile Directorate of Field Publicity) Central Bureau of Communication (Recruitment to Group 'D' posts) Rules, 1986 under G.S.R. No. 2 dated 23.12.2005, except as respect things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of **Multi Tasking Staff (MTS)**, in the Central Bureau of Communication, Ministry of Information & Broadcasting, namely:-

#### Short title and commencement:-

- (i) These rules may be called Central Bureau of Communication, **Multi Tasking Staff (MTS)**, Recruitment Rules, 2024.
- (ii) These Rules shall come into force on the date of their publication in the Official Gazette.

## 2. Number, classification and Level in Pay Matrix:-

Number of the said posts, classification and scale of pay attached there to shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

## 3. Method of recruitment, age limit, qualifications etc:-

Method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 13 of the said Schedule.

#### 4. Disqualification:- No Person

- a) Who has entered into or contracted a marriage with a person having a spouse living; or
- b) Who, having a spouse living, has entered into or contracted a marriage with a person, shall be eligible for appointment to any of the said posts;

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

#### 5. Power to relax:-

Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

## 6. Saving:-

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
