Advisory for Community Radio Stations

Subject: Status of GST and Bank Account details of CRS and processing of bills- reg

1. The current status of GST details (GST Applicable/GST Exempt) and bank account details of the Community Radio Stations (CRS), as submitted/updated by the CRS on the CBC vendor portal are mentioned against the respective agency code of each CRS in **Annexure 'A'** to this advisory. CRS are advised to verify their current status and in case of any discrepancy send an email to coavers@gmail.com. Please note that emails addressed to any other email ID shall not be monitored.
2. It is clarified that the treatment of GST on bills of CRS partners shall be governed as under: -

3. **All bills that have been returned, or against which the remarks "Remove GST Certificate" or "Remove GST Exemption Certificate" have been marked in the vendor login of ERP portal of CBC, shall be required to be resubmitted by the concerned CRS partners after due rectification as per the clarification provided in table above. The vendor portal shall remain open for the purpose of such resubmission from 01.08.2026 to 15.08.2026.**
4. It is reiterated that CRS have already been given adequate opportunities to rectify/submit their bank account details and GST status, including the opportunity given in February 2026 and the final opportunity in May 2026. It is clarified that requests by CRS to effect changes in the database from backend by the IT team shall not be entertained. Any data input pertaining to bank/GST details shall be taken only through the CBC vendor portal through the login of respective CRS.

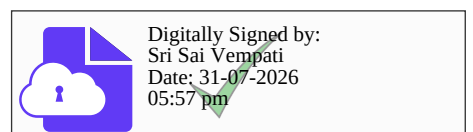
