Invitation of Bids for engagement of agency for organization of exhibitions on Flagship Schemes & Programs of Government of India.

1. Bids (Technical & Financial) in separate sealed covers are invited from Agencies for design and mounting of multimedia exhibition, on turn-key basis on the Flagship schemes & programs of Government of India with special focus Swachh Bharat, Fit India, Ek Bharat Shrestha Bharat and dissuading the use of Single Use Plastic among others. The details regarding the schemes to be focused in the exhibition are available at Annexure V. Detailed scope of Work is mentioned in Part-II of this RFP. Please superscribe the above-mentioned Title, RFP number and date of opening of the Bids on the sealed cover to avoid the bid being declared invalid. The bids should be submitted in separate sealed envelopes along with the soft copy in CD. **All the envelopes should be enclosed in another sealed envelope superscribed with the RFP number and due date.**

- Part IV: Contains special conditions applicable to this RFP and which will also form part of the contract with the successful bidder.
- Part V: Contains Evaluation Criteria and Format for Price Bids.
5. This RFP is being issued with no financial commitment and CBC, RO, Pune reserves the right to change or vary any part thereof at any stage. CBC, RO, Pune also reserves the right to withdraw the RFP at any stage.

Part I – General Information

- 1. Pre-Bid Conference and Briefing: 31/10/2022 at 02:30 PM** in Conference Hall, Ground Floor Carrier Building, Mahadji Shinde BSNL TE Compound, Near Poona Club, Camp, Pune
- 2. Last date and time for submitting the Technical & Financial Bids: 11/11/2022 – on or before 09:30 AM;** The sealed Bids should be deposited / reach by the due date and time. The responsibility to ensure this lies with the Bidder.
- 3. Manner of depositing the Bids:** Sealed Bids (Technical and Financial) should be submitted at the address mentioned in para (3) at first page of this RFP, by hand or by registered post so as to reach by the due date and time. **Late tenders will not be considered. No responsibility will be taken for postal delay or non-delivery/ non receipt of Bid documents. Bids sent by FAX or e-mail will not be considered.** Only those bids which are submitted to the mentioned address within due date and time will be opened.

4. **Time and date of opening of Technical Bids and Technical Presentation: 11/11/2022 – 10:00 AM**
(If due to any exigency, the due date for opening of the proposals is declared a closed holiday, the proposals will be opened on the next working day at the same time or on any other day/time, as intimated by the CBC, RO, Pune.)
5. **Place of opening the Bids & Presentation:**
Conference Hall, Ground Floor Carrier Building, Mahadji Shinde BSNL TE Compound, Near Poona Club, Camp, Pune. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of technical Bids on the due date and time. The eligible agencies will be decided based on the qualification documents and all the qualified will be allotted time slot on the same day for Technical presentation in the same venue. **The Bidders will have to come prepared for the Technical presentation on the mentioned date. This event will not be postponed due to non-presence of representative of any Bidder.**
6. **Forwarding of Bids:** Bids should be forwarded by the Bidders under their original memo/letter pad inter alia furnishing all details/documents as mentioned in para 2 (qualifying criterion) of page 1 like PAN Number, GST Number, Bank Branch address with e-payment Account etc. with complete postal & e-mail address of their office and the mobile number on which the Agency can be contacted.
7. **Clarification regarding contents of the RFP:** A prospective bidder who requires clarification regarding the contents of the bidding documents may forward the queries vide e-mail to – ro.pune.dfp@nic.in referring the RFP title, number and date, not later than 2 days prior to the last date of submission of the Technical Bids. Copy of the queries and CBC, RO, Pune's clarification shall be posted on our website –www.davp.nic.in for information of all prospective bidders.
8. **Modification and Withdrawal of Bids:** A bidder may modify or withdraw his/her bid after submission provided that the written notice of modification or withdrawal is received by CBC, RO, Pune prior to deadline prescribed for submission of bids. A withdrawal notice may be sent by e-mail but it should be followed by a signed confirmation copy to be sent by post and such signed confirmation should reach CBC, RO, Pune not later than the deadline for submission of bids. **No bid shall be modified after the deadline for submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiration of the period of bid validity specified. Withdrawal of a bid during this period will result in Bidder's forfeiture of bid security.**
9. **Clarification regarding contents of the Bids:** During evaluation and comparison of bids, CBC, RO, Pune may, at its discretion, ask the bidder for clarification of his/her bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. **No post-bid clarification on the initiative of the bidder will be entertained.**
10. **Rejection of Bids:** Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection with forfeiture of EMD. **Conditional tenders will be rejected.**
11. **Validity of Bids:** The Bids should remain valid for a period of **one year** from the last date of submission of the Bids.

- 12. Earnest Money Deposit:** Bidders are required to submit Earnest Money Deposit (EMD) for an amount of Rs. 1,00,000/- along with their bids except Micro and Small Enterprises (MSEs) as defined in MSME Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME). The EMD may be submitted in the form of an Account Payee Demand Draft / Banker's Cheque in favour of Sr. Accounts Officer, ROB, Pune or Bank Guarantee from any of the Public Sector Banks or a private Sector Bank authorized to conduct government business as per Annexure-I. EMD is to remain valid for a period of forty-five days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. **The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender.**
- 13. Two bid system:** It is a two-bid system. The proposal of the Agencies, who meet eligibility criterion, will be evaluated based on their technical presentation. Date of opening of financial/price bid is **11.11.2022** after technical presentation in Conference Hall, Ground Floor Carrier Building, Mahadji Shinde BSNL TE Compound, Near Poona Club, Camp, Pune. **Financial/price bids of only those firms will be opened, whose technical bids are found compliant/suitable after technical evaluation is done by CBC, RO, Pune.**
- 14. Preparation of Proposal:** The Respondent shall comply with the following related information during preparation of the proposal-
- The Proposal shall conform to provisions of RFP. Any interlineations, erasures or over writings shall be valid only if they are initialed by the authorized person signing the Proposal.
 - The Proposal shall be typed or written in indelible ink (if required) and shall be signed by the Respondent or duly authorized person(s) to bind the Respondent to the contract. The letter of authorization shall be indicated by written power of attorney and shall accompany the Proposal.
 - Proposals received by facsimile shall be treated as defective, invalid and rejected. Only detailed complete proposals in the form indicated above received prior to the closing time and date of the proposal shall be taken as valid.

Part II – Essential Details of Services Required

1. Creative Brief

- Aim & Objective:** Central Bureau of Communication, Regional Office, Pune, Ministry of Information & Broadcasting, Government of India, having 11 field offices located across Maharashtra & Goa, is responsible for creating awareness on important social issues and flagship programs of Government of India (Annexure V). CBC, RO, Pune invites technical and financial proposals for **“The Flagship schemes & programs of Government of India with special focus on Swachh Bharat, Fit India, Ek Bharat Shrestha Bharat and dissuading the use of Single Use Plastic among others”**. There are **16 exhibitions in total** and they have been categorized into Big Scale Multi-media digital exhibitions and Medium Scale Exhibitions. **The exhibitions are proposed to be organized from November, 2022 to March, 2023. The tentative list of locations for both the type of exhibition is at Annexure VI. The location may be at distant rural areas also.** The location may change if the condition so demands. All the exhibits are intended to be in Marathi, Hindi & English. The selected agency must design, fabricate, install and run the exhibition during the proposed time period on turn-key basis. Details as regarding tentative schedule for the exhibitions **(November, 2022 to March, 2023)** will be provided to the selected agency at the time of awarding of contract.

- b) **Target Audience:** The target audience will be general public, Youth, Students, women, etc who will visit the venue of exhibition.

2. **Scope of Works:**

A. The scope of the work is as follows:

- a) **For Big scale multi-media exhibitions at Six locations, Nanded, Jalna, Ahmednagar, Goa, Solapur & Nagpur for 5 days at each location. Ideation, conceptualization, duration, research, scripting, layout and designing and mounting the exhibition on turn-key basis.**

This design and execution must include the following items:

- Creative designs for display showcasing the flagship schemes of government of India and success stories
- Conventional exhibition panels with vinyl foam printing, Backlit panels - rotating and static, Standees, Banners, Signature Board, etc. befitting the venue
- Innovative digital means of engaging audiences – LED Panels, LED TVs, LED Walls, Touch kiosks, Virtual Reality (VR) experience, Augmented Reality (AR) experience, Sound showers, Holographic Projection or immersive display, and other interactive digital media providing personalized experience
- Fabrication & Installation of display aids
- Engaging subject experts for research, scripting **and content developing.**
- Photo booths/ Selfie Corners with innovative ideas- linkage with social media
- Organizing online quiz competition based on flagship initiatives of Govt of India with certificate print-outs to the participants
- Artistic gates with artwork, logos, mural, highlighting the theme & name of Departments in Hindi and English (2 in number)
- Designing of an appropriate fascia & entrance lobby in innovative form
- Innovative and interactive games for engagement of audience
- Creation of relevant Hashtags and innovative ways to make the same trending on social media
- Creation of virtual community for interaction/exchange of ideas during and after exhibition
- Compilation of a final report (2 copies to be given to CBC, RO, PUNE) and 2-3 minutes video capsule, including drone shooting.
- Developing good quality Audio-Visual content for pre publicity
- The deliverables of the interactive personal experience may not be limited to the above mentioned items. The bidder may suggest more innovative ideas.

b) For Medium Scale exhibitions at 10 locations for 3-4 Days at each location: (on turn-key basis)

- Creative designs for display showcasing the flagship schemes of government of India and success stories
- Conventional exhibition panels with vinyl foam printing, Backlit panels - rotating and static, Standees, Banners, Signature Board, etc. befitting the venue
- Innovative digital means of engaging audiences – LED Panels, LED TVs, LED Walls, Touch kiosks, Virtual Reality (VR) experience, Augmented Reality (AR) experience, Sound showers, Holographic Projection or immersive display, and other interactive digital media providing personalized experience
- Fabrication & Installation of display aids

B. Exhibition Infrastructure:

a. For Big Scale multi-media digital exhibitions at 6 locations

- Tent/Hangar/Pandal structure (in 4000-5000 sq ft area) with a stage, sofas, centre table and backdrop for inauguration ceremony, cultural activities, performances and public function with seating capacity of around 200 people with all sound, light and other required support
- Podium with **3 microphones instrument with stand and 2 wireless microphones**.
- 6 stalls (10 X 10 ft) with 12 tables & chairs

- Refreshments for guests on inaugural day
- House-keeping staff for regular cleaning of Exhibition venue and Security guards
- 15 banners (6X3 ft) around the exhibition venue and important places of the city.
- Professional Photography and Videography on the inaugural day
- CCTV cameras at the venue with monitoring and recording facility
- Power supply along with back-up
- Fans, Coolers, Fire extinguishers, etc. at the exhibition venue
- Decoration of the whole venue befitting the occasion
- Mechanism to measure & ascertain footfall
- **Welcome of the guests on inaugural day with flowers/ bouquets/ mementos.**

b. For Medium Scale exhibitions at 10 locations

- Tent/Hangar/Pandal structure (in 2000-3000 sq ft area) with a stage, sofas, centre table and backdrop for inauguration ceremony, cultural activities, performances and public function with seating capacity of around 200 people with all sound, light and other required support.
- Podium with microphones- 3 with stand and 2 wireless;
- 3 stalls (10 X 10 ft) with 06 tables & chairs
- Refreshments for guests on inaugural day
- Welcome of the guests on inaugural day with flowers/ bouquets/ mementos
- Decoration of whole venue befitting the occasion
- House-keeping and security staff
- Fans, Coolers, Fire extinguishers, etc. at the exhibition venue
- Decoration of the whole venue befitting the occasion
- Professional videography and photography on the inaugural day
- 10 banners (6X3 ft) around the exhibition venue and important places of the city
- Highlights of the exhibition in the form of a short video of 3-minute duration.
- CCTV cameras at the venue with monitoring and recording facility
- Mechanism to measure & ascertain footfall

Maintenance (Exhibition):

- The scope of work will also include maintenance activities during the event and dismantling of the structure after the event and all the other ancillary works relating to it
- Housekeeping & security of display area
- One reception/information counter table with stationary like visitor books, pens, scissors, ribbon, tray, inaugural lamp, etc. (only for exhibition)
- PA system & sound System
- Fire extinguishers & fire men on duty

- Earthing & Cabling as per venue norms
- All Licenses / NOC from relevant Govt. authorities for show operation
- Providing plants to add a green touch to the Pavilion, electrical fittings in the pavilion as per requirements, as well as daily cleaning of the pavilion during the course of the exhibition

Specifications and auxiliary requirement

- All material to be used in application should be ISI Marked & ISO Standards. Material specifications should be of standard premium company make
- In addition to the above mentioned scope of work, the agency must execute any other work assigned by CBC RO Pune as per the requirements of the exhibition venue/ occasion

3. The Task / Schedule of Requirements: The agency must execute all the works as mentioned in scope of work and the accepted technical proposals. The exhibition venue with all design, fabrication, installation and facilities (as per accepted proposal / contract) should be completely ready 12 hours before the inauguration time of the exhibition. The agency must maintain the venue for all the exhibition days and will also be responsible for de-installation / clearing the venue after completion of the exhibition.

4. Period of Contract: The contract shall be valid **till 31st March 2023 from the effective date of contract, and extendable by one more year up to 31st March 2024, with mutual consent and on agreed terms and conditions.** Please note that Contract can be cancelled unilaterally by CBC, RO, Pune being customer, in case, services are not received as per quality and standard specified in the RFP and contract within the contracted period. CBC, RO, Pune reserves the right to exercise the option clause and repeat the order clause as per text given in Part IV of this RFP.

Part III – Standard Conditions of RFP

The Bidder is required to give confirmation of their acceptance of the Standard Conditions of the Request for Proposal mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder (i.e. Contractor/Supplier in the contract) as selected by CBC, RO, Pune. Failure to do so may result in rejection of the Bid submitted by the Bidder.

1. Law: The Contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.

2. Effective Date of Contract: The contract shall come into effect on the date of signatures of both the parties on the contract (Effective Date) and shall remain valid until the completion of the obligations of the parties under the contract. The deliveries and supplies and performance of the services shall commence from the effective date of the contract.

3. Arbitration: All disputes or differences arising out of or in connection with the contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the Contract or relating to services or performance, which cannot be settled amicably, may be resolved through arbitration. The standard clause of arbitration is given in Annexure-II.

4. Penalty for use of Undue influence: The agency undertakes that it has not given, offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person in service of CBC, RO, Pune or otherwise in procuring the Contracts or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the present Contract or any other Contract with the Government of India for showing or forbearing to show favour or disfavor to any person in relation to the present Contract or any other Contract with the Government of India. Any breach of the aforesaid undertaking by the agency or any one employed by it or acting on its behalf (whether with or without the knowledge of the agency) or the commission of any offence by the agency or anyone employed by it or acting on its behalf, as defined in chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1986 or any other Act enacted for the prevention of corruption shall entitle CBC, RO, Pune to cancel the contract and all or any other contracts with the agency and recover from the agency the amount of any loss arising from such cancellation. A decision of CBC, RO, Pune or its nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the agency. Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the agency towards any officer/employee of CBC, RO, Pune or to any other person in a position to influence any officer/employee of CBC, RO, Pune for showing any favour in relation to this or any other contract shall render the agency to such liability/penalty as CBC, RO, Pune may deem proper, including but not limited to termination of the contract, imposition of penal damages, forfeiture of the Bank Guarantee and refund the amounts paid by CBC, RO, Pune.

5. Agents/Agency Commission: The agency confirms and declares to CBC, RO, Pune that the agency is the original provider of the services referred to in this Contract and has not engaged any individual or firm, whether Indian or foreign whatsoever, to intercede, facilitate or in any way to recommend to the Government of India or any of its functionaries whether officially or unofficially, to the award of the contract to the contractor, nor has any amount been paid, promised or intended to be paid to any such individual or firm in respect of any such intercession, facilitation or recommendation. The agency agrees that if it is established at any time to the satisfaction of CBC, RO, Pune that the present declaration is in any way incorrect or if at a later stage it is discovered by CBC, RO, Pune that the contractor has engaged any such

individual/firm, and paid or intended to pay any amount, gift, reward, fees, commission or consideration to such person, party, firm or institution, whether before or after the signing of this contract the agency will be liable to refund that amount to the CBC, RO, Pune. The agency will also be debarred from entering into any supply Contract with the Government of India for a minimum period of five years. CBC, RO, Pune will also have a right to consider cancellation of the Contract either wholly or in part, without any entitlement or compensation to the agency who shall in such an event be liable to refund all payments made by CBC, RO, Pune in terms of the contract along with interest at the rate of 2% per annum above 18% penal rate. The CBC, RO, Pune will also have the right to recover any such amount from any contracts concluded earlier by agency with the Government of India or with CBC, RO, Pune.

6. Access to Books of Accounts: In case it is found to the satisfaction of CBC, RO, Pune that the agency has engaged an Agent or paid commission or influenced any person to obtain the contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the agency, on a specific request of CBC, RO, Pune shall provide necessary information/inspection of the relevant financial documents/information.

7. Non-disclosure of Contract documents: Except with the written consent of CBC, RO, Pune, the agency shall not disclose the contract or any provision of the contract or information related to services thereof to any third party.

8. Penalty and Liquidated Damages: In the event of the Agency failure to submit the Bonds, Guarantees and Documents, provide the satisfactory services as specified in this contract, CBC, RO, Pune may, at its discretion, withhold any payment until the completion of the contract. CBC, RO, Pune may also deduct from the agency as agreed, liquidated damages to the sum of 1% of the contract price of the delayed services mentioned above for each day subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed services.

9. Termination of Contract: CBC, RO, Pune shall have the right to terminate this Contract in part or in full in any of the following cases:

- a. The delivery of the creatives are delayed for causes not attributed to Force Majeure for more than 5 days after the scheduled date of deliverable fixed by CBC, RO, Pune.
- b. The agency is declared bankrupt or becomes insolvent.
- c. The delivery of creatives is delayed due to causes of Force Majeure by more than 01 months.
- d. CBC, RO, Pune has noticed that agency has utilized the services of any agent in getting this contract and paid any commission to such individual/company etc.
- e. As per decision of the Arbitration Tribunal.
- f. As per Para (8) of Part IV of RFP.

10. Notices: Any notice required or permitted by the contract shall be written in the English language and may be delivered personally or may be sent by registered pre-paid mail/airmail, addressed to the last known address of the party to whom it is sent.

11. Transfer and Sub-letting: The agency has no right to give, bargain, sell, assign or sublet or otherwise dispose of the contract or any part thereof, as well as to give or to let a third party take benefit or advance of the present Contract or any part thereof.

12. Patents and other Intellectual Property Rights: The prices stated in the present Contract shall be deemed to include all amounts payable for the use of patents, copyrights, registered charges, trademarks

and payments for any other intellectual property rights. The Contractor shall indemnify CBC, RO, Pune against all claims from a third party at any time on account of the infringement of any or all the rights mentioned in the previous paragraphs whether such claims arise in respect of manufacture or use. The contractor shall be responsible for the completion of the services in satisfactory manner during the currency of the contract.

13. Amendments: No provision of present contract shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.

14. Statutory Duties & Taxes:

- a. Any change in any duty/tax upward/downward as a result of any statutory variation taking place within contract terms shall be allowed to the extent of actual quantum of such duty/tax paid by the agency. Similarly, in case of downward revision in any duty/tax, the actual quantum of reduction of such duty/tax shall be reimbursed to CBC, RO, Pune by the agency. All such adjustments shall include all reliefs, exemptions, Rebates, concession etc. if any obtained by the contractor.
- b. If it is desired by the Bidder to ask for the GST to be paid as extra, the same must be specifically stated. In the absence of any such stipulation in the bid, it will be presumed that the prices quoted by the Bidder are inclusive of GST and no liability will be developed upon CBC, RO, Pune.
- c. On the Bids quoting GST, the rate and the nature of GST applicable at the time of supply should be shown separately. GST will be paid to the agency at the rate at which it is liable to be assessed or has actually been assessed provided the transaction of services is legally liable to GST and the same is payable as per the terms of the contract.

15. Pre-Integrity Pact Clause: An "Integrity Pact" would be signed between CBC, RO, Pune & successful agency / bidder. This is a binding agreement between CBC, RO, Pune and Agency for specific contracts in which CBC, RO, Pune promises that it will not accept bribes during the procurement and services process and bidder promise that they will not offer bribes. Under this Pact, the Bidders for specific services or contracts agree with CBC, RO, Pune to carry out the procurement and services in a specified manner. Elements of the Pact are as follows:

- a. A pact (contract) between the CBC, RO, Pune (Principal) and successful Bidder for this specific activity (the successful Bidder);
- b. An undertaking by the Principal (i.e. CBC, RO, Pune) that its officials will not demand or accept any bribes, gifts etc., with appropriate disciplinary or criminal sanctions in case of violation;
- c. A statement by successful Bidder that it has not paid, and will not pay, any bribes;
- d. An undertaking by successful Bidder to disclose all payments made in connection with the contract in question to anybody (including agents and other middlemen as well as family members, etc. of officials); the disclosure would be made either at the time of signing of contract or upon demand of the Principal, especially when a suspicion of a violation by that successful bidder/contractor emerges;
- e. The explicit acceptance by successful Bidder that the no-bribery commitment and the disclosure obligation as well as the attendant sanctions remain in force for the winning Bidder until the contract has been fully executed.

- f. Undertaking on behalf of a successful Bidding agency will be made “in the name for and on behalf of the company’s Chief Executive Officer”.
- g. The following set of sanctions shall be enforced for any violation by a Bidder of its commitments or undertaking:
 - i) Denial or loss of contracts;
 - ii) Forfeiture of the bid security and performance bond;
 - iii) Liability for damages to the principal (i.e. CBC, RO, Pune) and the competing Bidders; and
 - iv) Debarment of the violator by the Principal (i.e. CBC, RO, Pune) for an appropriate period of time.
- h. Bidders are also advised to have a company code of conduct (clearly rejecting the use of bribes and other unethical behaviors and compliance program for the implementation of the code of conduct throughout the company).

Part IV-Special Conditions of RFP

The Bidder is required to give confirmation of their acceptance of Special conditions of the RFP mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder. (i.e. the Agency in the contract) as selected by CBC, RO, Pune. Failure to do may result in rejection of Bid submitted by the Bidder.

1. Performance Guarantee: The successful bidder will be required to furnish a Performance Guarantee by way of Bank Guarantee through a public sector bank or a private sector bank authorized to conduct government business (ICICI Bank Ltd., Axis Bank Ltd or HDFC Bank Ltd.) for a sum equal to 5% of the contract amount before signing of contract. Performance Bank Guarantee should be valid up to 45 days beyond the date of completion of Contract period. The specimen of PBG is given in Annexure III.

2. Option clause: The contract will have an Option Clause, wherein CBC, RO, Pune can exercise an option to hire service of the agency for additional number of deliverables as listed in the original contract in accordance with the same rate, terms & conditions of the present contract. This will be applicable within the currency of contract. The Bidder is to confirm the acceptance of the same for inclusion in the contract. It will be entirely the discretion of CBC, RO, Pune to exercise this option or not.

3. Repeat Order Clause: The contract will have a Repeat Order Clause, wherein CBC, RO, Pune can order up to same number of deliverables numbered under the present contract within currency of the contract at the same rate, terms & conditions of the contract. The Bidder is to confirm acceptance of this clause. It will be entirely the discretion of CBC, RO, Pune to place the Repeat Order or not.

4. Payment Terms: It will be mandatory for the Bidders to indicate their bank account numbers and other relevant e-payment details so that e-payments could be made instead of payment through cheques. The payment will be made upon satisfactory performance of work and no advance payment would be made at any cost.

5. Paying Authority: The payment would be made by CBC, RO, Pune on submission of following documents:

(i) Ink signed copy of the Agency's bills

(ii) Satisfactory Performance report submitted by supervising officer (wherever applicable as per the contract)

(iii) Details for electronic payment viz Account holder's name, Bank name, Branch name and address, Account type, Account Number, IFSC code, MICR code (if these details are not incorporated in supply order/contract).

(iv) Any other document / certificate that may be provided for in the Job Order / Contract.

(viii) Copy of PBG.

6. Fall Clause: The following Fall clause will form part of the contract placed on successful Bidder:

(a) The price charged for the services supplied under the contract by the Agency shall in no event exceed the lowest price at which the Agency provides the services of identical description to any persons/organization including CBC, RO, Pune or any department of the Central Government or any department of state government or any statutory undertaking of the central or state government as the case may be during the period till performance of all services placed during the currency of the contract is completed.

- (b) If at any time, during the said period the Agency reduces the service price or offer to provide services to any person/organization including CBC, RO, Pune or any department of the Central Government or any Department of the State Government or any Statutory undertaking of the Central or State Government as the case may be at a price lower than the price chargeable under the contract. Such reduction of services offer of the price shall stand correspondingly reduced.
- (c) The Agency shall furnish the following certificate to CBC, RO, Pune along with each bill for payment for services made against the contract – “We certify that there has been no reduction in service price of the services provided to the Government under the contract herein and such services have not been offered/sold by me/us to any person/organization including CBC, RO, Pune or any department of Central Government or any department of a state Government or and Statutory Undertaking of the Central or state Government as the case may be up to the date of bill/the date of completion of services against all job orders/contract placed during the currency of the Contract at price lower than the price charged to the government under the contract.”

7. Risk & Expense clause:

- i) Should the services thereof not be delivered within the time or times specified in the contract documents, or if defective services is made in respect of the services thereof, CBC, RO, Pune shall after granting the Agency seven days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of contract, to declare the contract as cancelled either wholly or to the extent of such default.
- ii) Should the services thereof not perform in accordance with the specifications/parameters provided by CBC, RO, Pune during the check proof tests to be done by CBC, RO, Pune, CBC, RO, Pune shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default.
- iii) In case of a contractual breach that was not remedied within 07 days, CBC, RO, Pune shall, having given the right of first refusal to the contractor be at liberty to provide services from any other source as he thinks fit, of the same or similar description to services
- iv) Any excess of the services price, cost of services or value of any services procured from any other contract as the case may be, over the contract price appropriate to such default or balance shall be recoverable from the Agency by CBC, RO, Pune.

8. Force Majeure Clause:

- a) Neither party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of services under the provisions of the present contract), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.
- b) In such circumstances the time stipulated for the performance of an obligation under the present contract is extended correspondingly for the period of time of action of these circumstances and their consequences.
- c) The party for which it becomes impossible to meet obligations under this contract due to Force Majeure conditions, is to notify in written form the other party of the beginning and cessation of the above circumstances immediately, but in any case not later than 10 (Ten) days from the moment of their beginning.

- d) Certificate of a Chamber of Commerce (Commerce and Industry) or other competent authority or organization of the respective country shall be a sufficient proof of commencement and cessation of the above circumstances.
- e) If the impossibility of complete or partial performance of an obligation lasts for more than one month either party hereto reserves the right to terminate the contract totally or partially upon giving prior written notice of 15 days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.

9. Misc. terms & conditions of the contract:

- The agency shall provide the required services as and when demanded by the CBC, RO, Pune. The personnel engaged for the services in the CBC, RO, Pune shall be the employees of the Agency and will take their remuneration/wages from the Agency. They will have no claim of whatsoever nature including monetary claim or any other claim or benefits from the CBC, RO, Pune. The Agency shall make its own arrangement for commuting the personnel requisitioned, to the CBC, RO, Pune offices wherever located in the areas and back.
- The agency will be responsible for compliance of all the applicable laws and obligations arising out from the action of providing the services. Any liability arising under Municipal, State or Central Govt. laws and regulations will be the sole responsibility of the Agency and the CBC, RO, Pune shall not be responsible for any such liability. The Agency shall undertake to indemnify the CBC, RO, Pune for any liability under any law arising out providing the services as per the contract.
- During the subsistence of the contract, the CBC, RO, Pune shall not undertake any monetary liability other than the amount payable to the Agency for the services as per the contract. Other liabilities, if any, shall be solely rest on the Agency. Even if the CBC, RO, Pune has to bear such liabilities on unforeseen circumstances/occasions, the CBC, RO, Pune will recover such amount from the Agency by adjusting the amount payable to them.
- The Agency shall comply with all acts, laws and other statutory rules, regulations, bye-laws, etc., as applicable or which might become applicable to the state of Rajasthan with regard to performance of the work included herein or touching upon this contract.
- If the Agency fails to provide satisfactory performance, the CBC, RO, Pune shall be at liberty to terminate the contract and withhold the Security Deposit or the balance payment of the contractor, etc. The CBC, RO, Pune reserves the right to abandon or terminate the contract at any time without assigning any reason and it can stipulate any additional term & condition at any time during the currency of the contract.

10. Indemnity:

- **Mutual Indemnification** - Each party shall defend and indemnify the other, its officers and employees from and against any damages to real or tangible personal property and / or bodily injury to persons, including death, resulting from its or its employees' negligence or willful misconduct.
- **Intellectual Property Indemnities** - Bidder shall defend and indemnify CBC, RO, Pune from and against any suit, proceeding, or assertion of a third party against CBC, RO, Pune based upon a claim that any of the system or part of the system supplied by the Bidder including third party components, infringes any valid patent, copy right, trade secret, or other intellectual property right under any country's national or international laws. If a claim pursuant to above occurs,

Bidder shall take all necessary remedial actions at its own cost. Bidders shall safe guard CBC, RO, Pune operations and protect CBC, RO, Pune against any penalty and / or liability arising out of such claim.

11. The Bidder shall bear all the costs associated with the preparation and submission of its bid, and CBC, RO, Pune will in no case be responsible or liable for these costs, regardless of conduct or outcome of bidding process.

12. The Bidder has to examine all instructions, forms, terms, conditions and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.

13. Amendment of Bidding Documents (Corrigendum)

- a. At any time prior to the deadline for submission of bids, CBC, RO, Pune may, for any reason, whether at its own initiative or in response to the clarification request by a prospective bidder, modify the bidding documents.
- b. In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids CBC, RO, Pune, at its discretion, may extend the deadlinefor the submission of bids.

Part V – Evaluation Criteria & Price Bid Issues

1. Evaluation Criteria: The selection of agency will be done through a two bid system i.e. ‘Technical’ and ‘Financial’. **All evaluation (Technical & Financial) would be done by a Committee duly constituted by the Competent Authority in CBC, RO, Pune.** During evaluation of Proposals, CBC, RO, Pune, may, at its discretion, ask the Respondents for clarification of their Proposals. The process for Evaluation / Selection is as given below:

- **Preliminary Scrutiny:** Preliminary scrutiny of the technical bids for eligibility will be done to determine whether the Proposal is complete, whether the documents have been properly signed and whether the bid is generally in order and given by due date. Bids not conforming to such preliminary requirements will be prima facie rejected.

- **Technical Evaluation: Technical proposal of the agency must detail the design framework and facilities for the exhibition as per the scope of work. The agencies will be required to give a presentation on their technical proposals.** Hard copy of the Technical proposal along with the presentation properly signed and stamped should be placed in the envelope. If a Technical Bid is determined as not substantially responsive, the committee will reject it. The parameters to be used for evaluation of technical proposal and presentation will be based upon:

Innovative mediums for engaging people with use of games, social media, etc in the exhibition	25 Marks

Total	100 Marks

- **Technically qualified Respondents: All agencies securing more than 60% marks in Technical Evaluation will be shortlisted by CBC, RO, Pune.** Financial Bids will be considered only of those respondents who secure a qualifying Technical Score of 60%
- **Financial Bids:** The Agencies are required to provide one financial proposal (in INR) (along with Technical Bids in separate envelopes properly marked and sealed) providing rates for Exhibition to cover the scope of work and activities as per their respective technical proposal. **Rate should be given in the format as per Annexure IV.** Financial Proposals will be opened in the presence of the Respondents who choose to be present. Lowest Rate (L1) will be calculated on the basis of financial bids submitted by technically qualified agencies.
- **The contract will be awarded to the such technically qualified Agency which quotes the Lowest Rate (L1 Rate). However, CBC, RO, Pune reserves the right to distribute the work amongst Agencies quoting the L2, L3, L4 rates, provided they agree to work at L1 rate. However, at least 40 % of the job will be awarded to Agency quoting the L1 rate.**
- The decision of the committee will be final and binding. CBC, RO, Pune reserves the right to accept or reject a proposal without assigning any reason thereof.
- The Bidders are required to spell out the rates of GST in unambiguous terms. In the absence of any such stipulation it will be presumed that the prices quoted are firm and no claim on account

of such taxes & duties will be entrained after the opening of tenders. If a Bidder is exempted from payment of GST up to any value of services from them, they should clearly state that no GST will be charged by them up to the limit of exemption by Government which they may have the documentary evidence for exemption of any statutory duties and taxes has to be produced along with price bid. If any concession is available in regard to rate/quantum of GST with the approval of Government, it should be brought out clearly. Stipulation like, GST is presently not applicable but the same will be charged if it becomes leviable later on, will not be accepted unless in such cases it is clearly stated by a Bidder that GST will not be charged by him/her even if the same becomes applicable later on. In respect of the Bidders who fail to comply with this requirement, their quoted prices shall be loaded with the quantum of GST which is normally applicable on the item in question for the purpose of comparing their prices with other Bidders.

- If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price will prevail and the total price will be corrected. If there is a discrepancy between words and figures, the amount in words will prevail for calculation of price.
- The Lowest Acceptable Bid will be considered further for placement of contract/supply order after complete clarification and price negotiations if required as decided by CBC, RO, Pune. CBC, RO, Pune also reserves the right to do Apportionment of Quantity, if it is convinced that Lowest Bidder is not in a position to provide the services within stipulated time and the same will be placed at Lowest-1rate.

2. **Award of Contract:** After final evaluation of the technical & financial proposal, CBC, RO, Pune will notify the successful Respondent in writing that their Proposal has been accepted.

3. **Disqualifications:** The CBC, RO, Pune on behalf of Government of India may at its sole discretion and at anytime during the evaluation of Bids / Proposals, disqualify any Respondent, if the Respondent has:

- a. Submitted the Proposal documents after the response deadlines.
 - b. Made misleading or false representation in the forms, statements and attachments submitted in proof of the eligibility requirements.
 - c. Exhibited a record of poor performance such as abandoning works, not properly completing the contractual obligations, inordinately delaying completion or financial failures, etc. in any project in the preceding three year.
 - d. Submitted a proposal that is not accompanied by required documentation or is non-responsive.
 - e. Failed to provide clarifications related thereto, when sought;
 - f. Submitted more than one Proposal;
 - g. Declared ineligible by the Government of India for corrupt and fraudulent practices or blacklisted;
 - h. Submitted a proposal with price adjustment/variation provision.
- The Respondent is expected to examine all the instructions, guidelines, terms and conditions as notified by CBC, RO, PUNE.

- (i) All disputes of differences arising out of or in connection with the present contract including the one connected with the validity of the present contract or any part thereof, should be settled by bilateral discussions.
- (ii) Any dispute, disagreement of question arising out of or relating to this contract or relating to construction or performance (except as to any matter the decision or determination whereof is provided for by these conditions), which cannot be settled amicably, shall within sixty (60) days or such longer period as may be mutually agreed upon, from the date on which either party informs the other in writing by a notice that such dispute, disagreement or question exists, will be referred to a sole Arbitrator.
- (iii) Within (60) days of the receipt of the said notice, an arbitrator shall be nominated in writing by the authority agreed upon by the parties.
- (iv) The sole Arbitrator shall have its seal in Jaipur or such other place in India as may be mutually agreed to between the parties.
- (v) The arbitration proceedings shall be conducted under the Indian Arbitration and Conciliation Act, 1996 and the award of such Arbitration Tribunal shall be enforceable in Indian Courts only.
- (vi) Each party shall bear its own cost of preparing and presenting its case. The cost of arbitration including the fees and expenses shall be shared equally by the parties, unless otherwise awarded by the sole arbitrator.
- (vii) The parties shall continue to perform their respective obligations under this contract during the pendency of the arbitration proceedings except in so far as such obligations are the subject matter of the said arbitration proceedings.

(Note: In the event of the parties deciding to refer the dispute/s for adjudication to an Arbitral Tribunal then one arbitrator each will be appointed by each party and the case will be referred to the Indian Council of Arbitration (ICADR) for nomination of the third arbitrator. The fees of the arbitrator appointed by the parties shall be borne by each party and the fees of the third arbitrator, if appointed, shall be equally shared by the Customer and Contractor.
